



2.9 Dealing with Infectious Diseases Policy

QUALITY AREA 2: Children's Health and Safety

Policy Statement

Bellingen Preschool is committed to providing a safe and healthy environment for all children, staff and any other persons attending the service by:

- preventing the spread of illness and disease through health and hygiene measures and policies. See policies 2.10; 2.12; 2.26 and 2.16.
- responding promptly and appropriately to the needs of the child or adult who presents with symptoms of an infectious disease or infestation while attending the service;
- complying with current exclusion schedules, regulations and guidelines set by the Department of Health, ACECQA, NSW Department of Education, the Australian Government; and
- providing up-to-date information and resources for families and staff regarding protection of all children from infectious diseases and blood-borne viruses, management of infestations and immunisation programs.

Goal

Bellingen Community Preschool will:

The way that children interact with each other and with adults in education and care services means that diseases can quickly spread in a variety of ways. Whilst it is not possible to prevent the spread of all infections and diseases, minimising the risk is enhanced through:

- effective hand washing, use of hand sanitisers and hygiene practices
- effective and vigilant cleaning procedures aligned with SafeWork NSW guide
- exclusion of ill children, educators and other staff
- immunisation; and
- following the advice of NSW Health

Bellingen Community Preschool Inc. is committed to minimising and identifying risks and hazards related to infectious diseases and health situations. These include epidemics, pandemics and outbreaks and responding to ensure the good health and care of all stakeholders, including the wider community. The preschool will work towards minimising the spread of illness and disease by staying up to date with current health advice, regulation and guidelines. The review of planned actions around handling these situations will include:

- Recognising the Duty of Care to meet the needs of the Preschool community and beyond. Conducting ongoing risk assessment and reviews of all potential health related issues and situations, including medical emergency situations, outbreaks and pandemics. This includes the recent COVID-19 Pandemic in 2020 (see Medical Conditions Policy, Infectious Disease Control Policy and COVID-19 Policy 2.9a).
- Develop specific procedures around ensuring the health of families, children and educators during health situations and pandemics and ensure full awareness of all staff through the provision of professional development.
- Consider the unique context of our community, our school and any health implications for children and educators attending the service at the time of illness/outbreak/pandemic, when making decisions.

Practices

Effective Hygiene

Our service will maintain and promote effective hygiene practices, including:

- correct handwashing technique;
- correct coughing and sneezing technique;
- maintaining physical distancing during times of outbreak, epidemic and pandemic as per Public health guidelines.
- Cleaning frequented surfaces regularly and following SafeWork cleaning guide <https://www.safeworkaustralia.gov.au/covid-19-information-workplaces/cleaning-prevent-spread-covid-19>
- Offering an outdoor program where possible, especially during times of outbreak, epidemic and pandemic
- using standard precautions when handling blood, all body fluids, secretions and excretions, dried blood and other body substances.
- cleaning toys and other items that children are likely to put in their mouths, after use;
- covering the sandpit when not in use;
- disposing of soiled items in bin that is inaccessible to children;
- washing rubbish bins regularly; and
- actively promote handwashing and other hygiene practices with children and families

Exclusion of Children, Educators and other Staff

Infectious Diseases

In order to prevent the spread of infectious diseases through interpersonal contact, our service will adhere to the exclusion period table, published by the Department of Health and any other Public Health advice.

Fever

In children, a temperature over 38°C indicates a fever.

A fever is usually caused by an infection somewhere in the body. Some types of infections that lead to fever include:

- viral (caused by a virus) – around nine out of ten children with a fever will have a viral illness, such as cold, flu, COVID-19 or gastroenteritis
- bacterial (caused by bacteria) – such as some ear infections, pneumonia or urine infections.

In order to prevent the spread of infection and ensure wellbeing, children with a temperature above 38°C will be excluded from the service and during a pandemic, epidemic or outbreak, be excluded until medical advice has been sought and child or adult cleared of serious illness.

Immunisation

The NSW Government Immunisation Toolkit for early childhood education and care services guides our practice and provides resources and information to support families access information regarding immunisation.

Under the Public Health Act 2010, education and care services cannot enrol a child unless approved documentation has been provided that shows the child:

- is fully vaccinated for their age, or;
- has a medical reason not to be vaccinated, or;
- is on a recognised catch-up schedule if the child has fallen behind with their vaccinations.

To enrol in our service, families must provide a copy of one or more of the following documents:

- AIR Immunisation History Statement which shows that the child is up to date with their scheduled vaccinations; or
- Medicare Immunisation History Form (IMMU13)** on which the immunisation provider has certified that the child is on a recognised catch-up schedule; or
- Medicare Immunisation Exemption - Medical Contraindication Form (IMMU11)** which has been certified by an immunisation provider, or;

Immunisation Exempt children

Non immunised children will be added to the service Non-Immunised Register.

- Non-immune children and Educators will be excluded from the service when there is an outbreak of a vaccine-preventable illness and required to remain away until the service is deemed

	<p>notified of the occurrence as soon as is practicable (Regulation 88(2)).</p> <ul style="list-style-type: none"> • Ensuring that information from the Department of Health about the recommended minimum exclusion periods is displayed at the service, is available to all stakeholders and is adhered to in the event of an outbreak of an infectious disease (as designated by the Department of Health – refer to Definitions). • Ensuring that the parent/guardian and Secretary are informed within 24 hours of becoming aware that an enrolled child is suffering from: <ul style="list-style-type: none"> a) Pertussis, or b) Poliomyelitis, or c) Measles, or d) Mumps, or e) Rubella, or f) Meningococcal C g) Covid-19 • Ensuring that a child who is not immunised against a vaccine-preventable disease does not attend the service when an infectious disease is diagnosed, and does not return until there are no more occurrences of that disease at the service and the recommended minimum exclusion period (refer to Definitions) has ceased (Regulation 85(2) of the Public Health and Wellbeing Regulations 2009). • Notifying the Regulatory Authority within 24 hours of a serious incident including when a child becomes ill at the service or medical attention is sought while the child is attending the service. • Ensuring that appropriate and current information and resources are provided to staff and parents/guardians regarding the identification and management of infectious diseases, blood-borne viruses and infestations. • Keeping informed about current legislation, information, research and best practice. • Ensuring that any changes to the exclusion table or immunisation schedule are communicated to staff and parents/guardians in a timely manner.
<p>Nominated Supervisor</p>	<ul style="list-style-type: none"> • Contacting the parents/guardians of a child suspected of suffering from an infectious or vaccine- preventable disease, or of a child not immunised against a vaccine-preventable disease that has been detected at the service, and requesting the child be collected as soon as possible. • Contact Department of Health if a notifiable disease. • Notifying a parent/guardian or authorised emergency contact person when a symptom of an excludable infectious illness or disease has been observed. • Ensuring that a minimum of one staff with current approved first aid qualifications is in attendance and immediately available at all times the service is in operation. • Establishing good hygiene and infection control procedures, and ensuring that they are adhered to by everyone at the service.
	<ul style="list-style-type: none"> • Ensuring the exclusion requirements for infectious diseases are adhered to as per the recommended minimum exclusion periods (refer to Definitions), notifying the Approved Provider and parents/guardians of any outbreak of infectious disease at the service, and displaying this information in a prominent position. • Advising parents/guardians on enrolment that the recommended minimum exclusion periods will be observed in regard to the outbreak of any infectious diseases or infestations.

	<ul style="list-style-type: none"> • Advising the parents/guardians of a child who is not fully immunised on enrolment that they will be required to keep their child at home when an infectious disease is diagnosed at the service, and until there are no more occurrences of that disease and the exclusion period has ceased. • Requesting that parents/guardians notify the service if their child has, or is suspected of having, an infectious disease or infestation. • Providing information and resources to families to assist in the identification and management of infectious diseases and infestations. • Maintaining confidentiality at all times. • Provide relevant sourced materials to families. • Ensuring that an “Incident, Injury, Trauma and Illness” record is completed as soon as practicable or no later than 24 hours of the illness occurring
Early Childhood Educators	<ul style="list-style-type: none"> • Ensure that any children that are suspected of having an infectious illness are responded to and their health and emotional needs supported at all times. • Implement appropriate health and safety procedures, when tending to ill children. • Ensure that families are aware of the need to collect their children as soon as practicable to ensure the child’s comfort. • Maintain their own immunisation status, and advise the Approved Provider/Nominated Supervisor of any updates to their immunisation status. • Provide varied opportunities for children to engage in hygiene practices, including routine opportunities, and intentional practice. • Observing signs and symptoms of children who may appear unwell, and informing the Nominated Supervisor. • Providing access to information and resources for parents/ guardians to assist in the identification and management of infectious diseases and infestations. • Monitoring any symptoms in children that may indicate the presence of an infectious disease. • Maintaining confidentiality at all times. • Remaining at home if not well and seeking medical advice.
Families	<ul style="list-style-type: none"> • Providing Immunisation documentation upon enrolment and as administered. • Keep their children at home if they are unwell or have an excludable infectious disease. • Keep their children at home when an infectious disease has been diagnosed at the service and their child is not fully immunised against that infectious disease, until there are no more occurrences of that disease and the exclusion period has ceased. • Inform the service if their child has an infectious disease or has been in contact with a person who has an infectious disease.
